

LIMITED WARRANTY

WHAT IS COVERED & FOR HOW LONG?

For a period of 6 months from the date it is shipped from our facility, on all Boyce Equipment rebuilt or new products, Boyce Equipment & Parts Co., Inc. will at its option repair or replace the products supplied by Boyce Equipment as part of the original components assembly that became unserviceable due to defect in workmanship or material. (See "Conditions & Limitations")

Boyce Equipment will repair the product at no charge to the purchaser at our Ogden, UT Facility. The purchaser is responsible for shipping costs to return the product to Boyce Equipment for repair. In some cases Boyce Equipment may elect at its sole option, to pay for all return shipping costs and make necessary arrangements for the return of the defective products. All repaired products will be returned to the purchaser freight prepaid.

In lieu of returning the product for repair, Boyce Equipment may offer to send the replacement parts, components, or assemblies to the purchaser at no charge. The replacement product will be sent to the purchaser freight prepaid. If the replacement part option is elected, the purchaser must pay all charges for the installation of the replacement product. The purchaser must package for return all defective parts, components, or assemblies replaced as part of the Warranty to Boyce Equipment. Boyce Equipment will pay for all shipping costs and make necessary arrangements for the return of the defective parts, components, or assemblies replaced by the customer as part of this Warranty.

PURCHASER'S OBLIGATIONS

Within 10 days from the time the defect becomes apparent.

Proper care and maintenance is necessary to obtain optimal performance and reliability from the axle assembly. It is the purchaser's obligation to see that the axle assemblies are installed, operated, and maintained in a safe manner in accordance with OEM and Dana service Manuals, and any applicable Boyce Equipment service bulletins.

CONDITIONS & LIMITATIONS

- 1- This Warranty DOES NOT cover:
 - A- Loss of time, inconvenience, loss of use of vehicle, towing fees, hotel or telephone bills, or incidental or consequential damages.
 - B- Damage or premature wear due to road hazard, wreck, collision, competition, use, vandalism, overloading, improper installation, customer installed attachments, misapplication, wheel/hub imbalance, mechanical condition of the unit, misuse, failure to provide proper maintenance, willful abuse or alteration of the axle assembly.
 - C- Normal wear, the attachment of the axle to the vehicle or the connection of brake hydraulic lines, cables, or wiring.
- 1- Boyce Equipment makes no other warranties express or implied, including warranties of or merchantability or fitness for a particular purpose. Purchaser is solely responsible for determining the adequacy of the product for any and all uses for which the purchaser may apply the product.
- 2- **IMPORTANT:** In accordance with Federal Law, this Warranty has been designated as a "Limited Warranty". Nothing in this Warranty is intended to be a representation by Boyce Equipment that axle assembly failures cannot occur.
- 3- Boyce Equipment does not cover any item sold "as is" or in "used condition".

CONSUMER RIGHTS

This Warranty gives you specific legal rights, and you may also have other rights that vary from state to state.
